Ua mālama 'ia ka hui kūkā 'ana o ka Papa Alaka'i i loko o ke ke'ena po'oku kumu o Ke Kula Ni'ihau O Kekaha a ma o ka Zoom ma ka Pūnaewelee. 'O nā lālā i hō'ea mai, 'o ia nō ka Hope Pelekikena Koana Acoba, ka Pu'ukū Hōkūlani Cleeland, nā lālā Thomas Nizo a me Keli'i Vidinha, a me ka lālā kū kūlana Tia Koerte, a me Ka'i'ini Nī'au, a ua kipa mai nō ho'i 'o Pua Ka'ai o ke Komikina Kula Ho'āmana. 'A'ole i hō'ea mai ka Pelekikena Kapua Phillips, ke Kākau 'Ōlelo Ka'ohu Kelley, a me ka lālā Sariah Kanahale, a 'a'ole i loa'a 'o Malia Melchor no ka māhele kālā.

Ka Wehe 'ana

I ka hola 3:07 o ka 'auinalā Po'akolu, lā 20 o Ianuali 2021, na Hōkūlani i wehe i ka hui kūkā 'ana me ka Pule Kahikolu, a na Koana i alaka'i i ke kūkā 'ana i nā kumuhana ma ka papa kumumana'o o ka hui kūkā. *At 3:07 p.m. on Wednesday, 20 January 2021, Hōkūlani opened the meeting with the Pule Kahikolu, and Koana led the discussion of items on the agenda.*

Ka Hui Kūkā 'ana:

- 1. Ka Mo'olelo Kahiko:** Ua 'āpono 'ia ka mo'olelo o ka hui kūkā 'ana o ka lā 21 o 'Okakopa 2020 e like me ka mea i kāka'ahi 'ia. *The minutes of the October 21, 2020, meeting were approved as distributed.*

- 2. Ka Papa Kumumana'o no kēia Hui Kūkā 'ana:** Ua 'āpono 'ia ka papa kumumana'o i hāpai 'ia e like me ka mea i kāka'ahi 'ia. *The proposed agenda was approved as distributed.*

3. **Ka Hō'ike Kālā:** Na Malia Melchor i hana i ka hō'ike kālā no kēia hapahā. Ua kūkā 'ia a na Tia i hāpai i ka mana'o pono e ho'one'e 'ia kekahi o nā pu'u kālā i hō'ike 'ia, a nāna nō e kūkā me Malia no ka ho'oponopono 'ana. No laila, ua noi 'ia e ho'opane'e i ka 'āpono kūhelu 'ana i ka hō'ike kālā a hiki i ka ho'opololei 'ia e Malia. *Malia Melchor prepared the quarterly financial report. During discussion, however, Tia noted that some of the amounts were misplaced and she would discuss with Malia the corrections that need to be made. Therefore, it was moved to table final approval of the financial report until corrections are made.*

4. **Ka Hō'ike Po'o Kumu:** Eia kekahi o nā mana'o i hāpai 'ia e Tia ma kāna hō'ike po'o kumu: **Pahuhopu 1:** Ua komo nā kumu kula pepe a me Tia lāua 'o Nui Parongao i loko o ka papa ECED 110, a aia 'o Hōkūlani i loko o ka papa KHAW 490 mai ke Kulanui O Hawai'i ma Hilo mai. **Pahuhopu 2:** Ua 'āpono 'ia kekahi ha'awina kālā no ka ho'omau 'ana i ka hana pakanā 'ana me Hamline a hiki i ka pau 'ana o lune 2021. **Pahuhopu 3:** E mau ana ka loa'a 'ana o nā ha'awina kālā no Title I, Kamehameha Schools, OHA, a me Kekaha. **Pahuhopu 4:** He 60 haumāna ka huina nui ma ka lā 7 o Ianuali 2021, me nā haumāna 7 ma ke kula pēpē i loko o ia helu. **Pahuhopu 5:** Ua loa'a 'ekolu 'aelike no ka mālama 'ana i ke kula, 'o ia ho'i, no ka mālama 'ana i nā paipu wai (a pēlā aku), ka hale kula, a me nā mīkini hō'olu 'ea ('a'ole i pa'a kēia 'aelike). **Pahuhopu 6:** Ua pa'a ka lā 23 o Ianuali no kekahi lā mālama kula me ka ho'omākaukau 'ana i ka 'āina o hope o ka hale kula no nā kula wai a me kekahi māla meakanu wa'a. **Pahuhopu 7.** E ho'omaka koke ana ka loiloi kumu no kēia makahiki kula; 'a'ole na'e i pau ka loiloi 'ana i ke po'o kumu no ka makahiki kula 2019–20. **He mau mana'o 'ē a'e:** (1) He kula ho'āmana ke kula no nā papa mālaa'o a hiki i ka papa 12, a i kēia manawa, ho'okomo pū 'ia ke kula pēpē e ka 'Aha'ōlelo. E loa'a ana \$154,000 no ia māhele hou o ke kula. (2) Pono e 'āpono 'ia e ka Papa Alaka'i ka hō'ike iā WASC no ka holomua o ka hana, a ua loa'a 'elua māhele i pili i ka hana a ka Papa Alaka'i. (3) 'A'ole e hana 'ia ana nā lā ho'omaha kumu e ke Kia'āina i kēia manawa; ke no'ono'o nei 'o Tia e pili ana i ka hana kūpono no ka makahiki 2021–22. (4) Ua hāpai nō ho'i 'o Tia i kekahi mau mana'o 'ē a'e e pili ana i ke kula, iā ia iho, a me ka 'aelike me ka 'uniona HGEA. *The following topics were discussed by Tia in her administrator's report: **Goal 1:** All the preschool staff plus Tia and Nui Parongao have enrolled in the ECED 110 class, and Hōkūlani is taking KHAW 490 from UH*

*Hilo. **Goal 2:** A grant has been approved to continue our partnership with Hamline University until the end of June 2021. **Goal 3:** Funding continues for this year from Title I, Kamehameha Schools, OHA, and the Kekaha Grant. **Goal 4:** Current enrollment as of January 7, 2021, is 60 students which includes 7 preschoolers. **Goal 5:** Three contracts are in effect for maintaining school property; these include plumbing, building maintenance, and AC repair and maintenance (still pending). **Goal 6:** January 23 is scheduled for a “mālama kula” event to prepare the back area for aquaponics and a canoe-plant garden. **Goal 7:** Teacher evaluations will begin soon for this school year; evaluation of the principal, however, has not been completed for the 2019–20 school year. **Some other concerns:** (1) The school is a charter school for grades K–12, but our charter now includes the preschool due to action taken by the Legislature. (2) The Board needs to approve the WASC action plan, which includes two sections related to the GB. (3) No furloughs are currently planned by the Governor for teachers; Tia is developing a plan for the 2021–22 school year. (4) Tia also brought up some personal concerns about the school in general, about herself, and regarding an agreement with the HGEA union.*
