

**Mo‘olelo no ka Hui Kūkā ‘ana  
o ka Papa Alaka‘i o  
Ke Kula Niihau O Kekaha**

**Po‘akolu, 16 ‘Apelila 2025**

Ua mālama ‘ia ka hui kūkā ‘ana o ka Papa Alaka‘i ma ka lumi nui o ke kula. ‘O nā lālā i hō‘ea mai, ‘o ia nō ka Pelekikena Keli‘i Vidinha, ka Hope Pelekikena Kapua Phillips (z), ke Kākau ‘Ōlelo Hōkūlani Cleeland, ka lālā kū kūlana Tia Koerte, ka lālā Brenda Jose, a me ke kanaka mālama kālā Glen Aoki. ‘Aole i hō‘ea mai ka Pu‘ukū Jolina Felix-Keamoai, Tiffani Carlin, U‘ilani Corr-Yorkman, Thomas Milimili Nizo, a me ka ‘elele Komikina Kula Ho‘āmana Pua Ka‘ai. **Ka Wehe ‘ana:**

I ka hola 3:00 o ka ‘auinalā Po‘akolu, lā 16 o ‘Apelila 2025, na Kapua i wehe i ka hui kūkā ‘ana me ka Pule Kahikolu, a na Keli‘i i alaka‘i i ke kūkā ‘ana i nā kumuhana ma ka papa kumumana‘o o ka hui kūkā. *At 3:00 p.m. on Wednesday, April 16, 2025, Kapua opened the meeting was with the Pule Kahikolu, and Keli‘i led the discussion of items on the agenda.*

**Ka Hui Kūkā ‘ana:**

- 1. Ka Mo‘olelo Kahiko:** Ua ‘āpono ‘ia ka mo‘olelo o ka hui kūkā ‘ana o ka lā 15 o Ianuali e like me ka mea i kāka‘ahi mua ‘ia. *The minutes of the January 15 meeting were approved as previously distributed.*
- 2. Ka Papa Kumumana‘o no kēia Hui Kūkā ‘ana:** Ua ‘āpono ‘ia ka papa kumumana‘o i hāpai ‘ia e like me ka mea i kāka‘ahi ‘ia. *The proposed agenda was approved as distributed.*
- 3. Ka Hō‘ike Kālā:** Ua kūkā ‘ia ka hō‘ike kālā no no ka hapahā ‘ekolu a Glen Aoki i hō‘ike mai ai ma o ka Zoom,; ua hana hou ‘ia ka hō‘ike me kekahi māhele hou e hō‘ike ana i kekahi mau mea no ke kālā o ke kula. Ua pane ‘o Glen i kekahi mau nīnau e pili ana i ka hō‘ike. *The financial report for the third quarter was discussed; the report had been updated with a new section providing more details about the school’s finances. Glen answered questions about the report.*

- 4. Ka Hō‘ike Po‘o Kumu:** Eia kekahi o nā mea a Tia i hāpai ai ma kōna hō‘ike:  
**Pahuhopu 1:** E hemo ana ‘o Tia me ke kēkelē ho‘ona‘auao ME i loko o Kekemapa. **Pahuhopu 2:** E mālama ‘ia ana ka lā Ho‘olaule‘a Puke i ka lā 30 o ‘Apelila, ka Lā Hānau i ka lā 14 o Mei, a me ka hemo kula i ka lā 27 o Mei. **Pahuhopu 4:** He 46 ka nui o nā haumāna mai ke kula pēpē a hiki i ka papa 12. **Pahuhopu 7:** E ho‘omaka ana ka Loiloi Kula WASC i ka lā 7 o Mei. *The following items were discussed by Tia in her report: Goal 1: Tia will be graduating with a master’s degree in education in December. Goal 2: A celebration of new books published will be held on April 30, the celebration for the school’s birthday will be held on May 14, and graduation will be on May 27. Goal 4: Total enrollment for preschool through grade 12 is now 46 students. Goal 7: The WASC accreditation will officially begin on May 7.*
- 5. Nā Hō‘ike Kōmike Kulana ‘Auhau ‘Ole a me ka ‘Imi Kālā:** Ke holomua nei ka huli ‘ana i ke kūlana 501(c)(3) e ke kōmike kulana ‘auhau ‘ole no kekahī hui e kōkua i ke kula. ‘O Brenda ke alaka‘i o ke kōmike, eia na‘e, ‘a‘ole i pa‘a loa ‘o wai ana ka pelekikena o ka hui 501(c)(3). *Plans for establishing a 501(c)(3) not-for-profit organization to help the school are progressing with the work of the committee. Brenda is the chairperson of the committee, but who will be the president of the 501(c)(3) organization has not yet been determined.*
- 6. Ka ‘Āpono ‘ana i nā Mea a pau:** Ke ‘āpono maoli nei ka Papa Alaka‘i i nā mea a pau i hō‘ike ‘ia i loko o kēia mo‘olelo. *Everything covered in these minutes is hereby officially approved by the Governing Board.*
