

**Mo'olelo no ka Hui Kūkā 'ana
o ka Papa Alaka'i o
Ke Kula Niihau O Kekaha**

Po'akolu, 16 Iulai 2025

Ua mālama 'ia ka hui kūkā 'ana o ka Papa Alaka'i ma ka lumi nui o ke kula. 'O nā lālā i hō'ea mai, 'o ia nō ka Pelekikena Keli'i Vidinha, ka Hope Pelekikena Kapua Phillips (z), ke Kākau 'Ōlelo Hōkūlani Cleeland, ka lālā kū kūlana Tia Koerte, ke kanaka mālama kālā Glen Aoki (z), a me kekahi malihini Billi Smith. 'Aole i hō'ea mai ka Pu'ukū Jolina Felix-Keamoai a me ka lala Thomas Milimili Nizo. Ua ne'e 'o Brenda Jose i ka hui 501(c)(3), a ke ho'omaha nei 'o U'ilani Corr-Yorkman. Ka Wehe 'ana:

I ka hola 3:05 o ka 'auinalā Po'akolu, lā 16 o Iulai 2025, na Keli'i i wehe i ka hui kūkā 'ana me ka Pule Kahikolu, a nana nō i alaka'i i ke kūkā 'ana i nā kumuhana ma ka papa kumumana'o o ka hui kūkā. *At 3:05 p.m. on Wednesday, July 16, 2025, Keli'i opened the meeting with the Pule Kahikolu, and he also led the discussion of items on the agenda.*

Ka Hui Kūkā 'ana:

1. Ka Mo'olelo Kahiko: Ua 'āpono 'ia ka mo'olelo o ka hui kūkā 'ana o ka lā 16 o 'Apelila e like me ka mea i kāka'ahi mua 'ia. *The minutes of the April 16 meeting were approved as previously distributed.*

2. Ka Papa Kumumana'o no kēia Hui Kūkā 'ana: Ua 'āpono 'ia ka papa kumumana'o i hāpai 'ia e like me ka mea i kāka'ahi 'ia. *The proposed agenda was approved as distributed.*

3. Ka Hō'ike Kālā: Ua kūkā 'ia ka hō'ike kālā no no ka hapahā 'ehā a hō'ike maila o Glen i na mea a ma o ka Zoom. Pane maila o Glen i keahi mau nīnau e pili i kāna hō'ike. *The financial report presented on Zoom for the fourth quarter was discussed, and Glen answered questions about the report.*

4. Ka Hō'ike Po'o Kumu: 'A'ole i loa'a mai ka hō'ike mai ka po'o kumu no nā mea hou no kēia wā, eia na'e, ua pau nā puke haumāna a pau i ke kākau a ho'oponopono 'ia, a ua pau nō ho'i nā mea a pau i ka pa'i 'ia. E mau ana nā hana 'ē a'e ma ke kula. *The principal's report on*

new activities for this period was not received, but all of the student books have been completed and printed. All other school activities are continuing

5. Ka Hō'ike Kōmike Kulana 'Auhau 'Ole: Ke holomua nei ka huli 'ana i ke kulanā 501(c)(3) e ke kōmike kulana 'auhau 'ole no kekahi hui e kōkua i ke kula. 'O Brenda ke alaka'i o ke kōmike, eia na'e, 'a'ole i pa'a loa 'o wai ana ka pelekikena o ka hui 501(c)(3). *Plans for establishing a 501(c)(3) not-for-profit organization to help the school are progressing with the work of the committee. Brenda is the chairperson of the committee, but who will be the president of the 501(c)(3) organization has not yet been determined.*

6. Ka 'Āpono 'ana i nā Mea a pau: Ke 'āpono maoli nei ka Papa Alaka'i i nā mea a pau i hō'ike 'ia i loko o kēia mo'olelo. *Everything covered in these minutes is hereby officially approved by the Governing Board.*
